Rural and Regional (RAR) Branches Advocacy Working Group - Formed September 2023 To advocate for rural and regional Labor members and branches and find solutions to structural problems that affect country branches and country representation.

Rules Revision Working Group - Formed September 2023

To review and update the Committees rules and purpose to reflect the priorities and interests of country Victorians and provide for good governance.

Transport Working Group - Formed December 2023

To advocate for rural and regional transport needs and facilitate policy solutions where possible.

Landcare Working Group - Formed January 2024

To support Landcare in Victoria by advocating for policy solutions that will continue to deliver a strong program.

Research and Papers Undertaken

Rules Revision Working Group - Draft New CLX Rules

CLX established a Rules Revision Working Group in September 2023 to review its existing rules, to determine whether any updates or adjustments were needed to better position the committee to respond to current and future challenges.

Action: The result of this work is "Updated and Expanded Rules for Country Labor" which has been submitted for consideration at the 2024 State Conference.

Transport Working Group

The Transport Working Group is preparing a discussion paper that is investigating the following; northwest Victoria integrated rail system, future freight task issue, Benetook bypass, increasing freight rail, broad gauge issues, designing roads for freight movement, overtaking lanes on the Calder and Sturt highways and carbon emissions.

Actions Undertaken:

The Transport Working Group started the consultation process at a meeting held in Mildura in February.

Actions Upcoming: Meeting with the relevant Ministers to further these transport issues.

RAR Branches Advocacy Working Group

RAR Branches Advocacy Working Group is working on developing ways to;

- 1. Increase Labor 's visibility in country Victoria.
- 2. Strengthen and consolidate the Labor team by removing barriers between country and metro areas and increasing cohesion between country districts and regions.
- 3. Building campaign strategies and tools for country Victoria with a particular emphasis on non-held seats.

Actions Undertaken:

- 1. CLX communicated on the 5/12/23, the value and importance of Government representation at every announcement in rural and regional Victoria; that all policies need to consider how they will be rolled out regionally, from inception, and should include a Rural and Regional impact statement and a regional specific release document.
- 2. The Country Labor Newsletter has been restarted for 2024
- 3. The following three rule changes have been submitted for consideration at the 2024 State Conference;
 - a. Minimum requirements for Campaigning in State and Federal Elections
 - b. Membership Fee Sharing
 - Central financial support for campaigns for non-held Victorian Legislative Assembly Seats

4. Resolution: Cultural Diversity Affirmative Action Working Group

Motion

That State Conference resolves that a Cultural Diversity Affirmative Action Working Group (**the Working Group**) be created with the following terms of reference:

- 1. Development of a proposed rule change that would implement affirmative action targets for cultural diversity in the Party in accordance with principles as follows:
 - 1.1. A minimum percentage target that takes into account the cultural diversity of Victoria relative to its current representation within the Party, and would result in an increase on that representation;
 - 1.2. A scope that includes public office preselection and party positions elected on a statewide basis:
 - 1.3. Eligibility criteria designed to focus on increasing the representation of multicultural cohorts that are underrepresented in the scope outline in paragraph 1.2 by reference to their broader community population;
 - 1.4. Eligibility to be based on a member's identification(s) of their cultural background at the point of joining or renewing their membership;
 - 1.5. Noting the importance of intersectionality, a design such that the 50 per cent affirmative action target for women's representation, and any other affirmative action targets that are created concurrently or in future, are maintained in full;
- 2. Membership of the Working Group to consist of five representatives from each of:
 - 2.1. The Victorian Multicultural Labor Network Executive, whose co-convenors shall chair and convene meetings of the Working Group;
 - 2.2. The Multicultural Affairs & Population Policy Committee; with two further observing representatives from the Rules Revision Committee whose role shall be to advise the Working Group;
- 3. Consideration of developing a combined rule change proposal with any other working groups that may be developing affirmative action rule changes, with the aim of achieving consistency in design;
- 4. Circulation of the proposed rule change to appropriate constituent units of the Party prior to the deadline for proposed rule changes before the next meeting of State Conference (or submission of the proposed rule change from the Multicultural Affairs & Population Policy Committee if it resolves to do so).

Background

Labor is the party of multicultural Victoria because we have achieved so much in advancing inclusion. Now we must build on our achievements by seizing the opportunity to also be the only political party that substantively reflects Victoria's cultural diversity.

In doing so we will reinforce Labor's mission of equal opportunity and participation in our democracy. We will also build Labor's future by gaining the valuable perspective of people with lived experience in multicultural communities.

Advancing greater cultural diversity among representatives of our party is an urgent priority because Victoria is rapidly becoming more culturally diverse.

Almost one in two Victorians - and one in two of all Australians - are now either born overseas or have at least one parent born overseas. As reported in Fairfax media, about a quarter of all Australians have a non-European, non-Indigenous background, compared to around 7% of Victorian Labor and 10% of Federal Labor parliamentarians.

Labor's proud history with affirmative action shows that if we say we are serious about reflecting diversity, we need mechanisms to ensure our actions reflect our aspirations. A mandated target is the best way to improve culturally diverse representation at the pace we need.

We also know that we need to get this proposal for cultural diversity affirmative action right. A working group which centres the experiences of those from multicultural backgrounds ensures that the proposal will be well-considered and reflect the best of Labor's values.

Victorian Labor has the unique opportunity to lead the way in our politics and demonstrate that we are the only party with a real commitment to culturally diverse representation. By creating a Cultural Diversity Affirmative Action Working Group, we can take a huge step towards fulfilling our values and building our future.
